Successful candidates will be expected to develop project plans and analyze documents submitted to the investigative committee, conduct research and investigations, conduct consultations with relevant royal families and stakeholders in terms of the applicable provisions of the TKLA, compile committee reports, give evidence as and when required and called upon to do so. Candidates whose profiles are successful will be appointed for a three-year period.

Appointed Members will be paid sitting and traveling allowances as determined by the Department of Public Service and Administration and the National Department of Transport.
