**Good Morning** 

My first official engagement upon my deployment to COGHSTA was a workshop on initiation schools hosted by the Provincial House of Traditional Leaders. I later presided over the launch of the initiation school season.

Looking at the agenda, I am hopeful that the Department can return to its multi-award winning pedigree. Our stationery still bear the legend, "Brought to you by multi-award winning Department," as an indication that we have not given up regain our greatness.

I am convinced that we can still be a multi-award winning Department. The colleagues, who made the Department a multi-award winner, are still here. As we celebrate our survival of the first wave of the pandemic and the reopening of the economy and other activities, let us get down to working and making a success of our mandates.

Among the items on the agenda is ICT Infrastructure and Network to support the new normal.

The pandemic has imposed the new normal on the world. Either we adapt to the new normal, or we die. Matters are as simple as that.

In the early days of the National Lockdown, we learnt and mastered to work virtually. This is the new way of doing things. It is no longer for the nerds who are ICT-savvy, but for all of us. We must put in place systems and structures to harness the Fourth Industrial Revolution to enhance our performance and be part of the highly competitive global village.

I owe you a word of gratitude for literally carrying the Department on your shoulders to this stage during a trying period in the history of humanity. Scientists are working hard against the clock to find a vaccine, and there is hope for a breakthrough soon and a return to a life of risks of the coronavirus.

Much progress was made during the meeting, and we are confident that a resolution will be found and the Vha-Venda Senior Traditional Leaders will resume their places and participation in the House.
