COGHSTA HELP DESK AT YOUR SERVICE



The Limpopo Department of Co-operative Governance, Human Settlements and Traditional Affairs (CoGHSTA) strives to ensure that all housing related queries are attended to speedily and its relationship with stakeholders grow from strength to strength through its Help Desk Services.

Ms Motlatle Reshoketswe, a Deputy Director and Manager of the Help Desk indicated that the purpose of her unit is to manage reception services and address service delivery complaints by members of the public. Operated by nine (9) officials, the departmental all Centers receives and

transmits large volumes of service delivery complaints relating to housing by telephone or walk-in clients and written complaints from the office of the HOD. "The most common queries that the Call Center come across on a daily basis are related to illegal occupation of houses and structural defects and houses," she said.

Motlatle outlines that the Center sometimes deals with housing complaints that were lodged years ago and were unable to be resolved. According to her, it is due to such unresolved complaints that the department developed a programme called Rectification,

aimed at tracing housing complains that could not be resolved years ago.

She further highlighted that the departmental Help Desk Services has scooped numerous awards. "Our unit has won Best Support Team at the Provincial Service Excellence, Best Innovative Team at the Departmental Service Excellence and the first runner up for Centre for Public Service Innovation (CPSI) awards," she boasted.

HUMAN SETTLEMENTS SCHOLARSHIP PROGRAMME

CHANGES LIVES OF YOUNG PEOPLE IN LIMPOPO

In an effort to close the skills gap in the Human Settlements industry, DoHS introduced the Human Settlements Scholarship Programme. The Programme started in 2008 and it is aimed at addressing skills development, to boost capacity also create opportunities related to the Housing Finance sector. In the process, exceptionally performing students who excel in Maths and Physical Science from previously disadvantaged groups in designated prioritised fields such as Quantity Surveying, Construction Management, Town and Regional Planning, Civil Engineering, Urban and Rural Studies are targeted.

Ms Rosina Rabekane, Deputy Director in Human Resources and Capacity Development and the Programme Manager indicated that the programme started in 2014. "The provincial government monitors and deals with the placement of Bursary Holders. So far we have placed twenty four (24) incumbents in CoGHSTA and many

people from Limpopo benefited from this programme. Every year we distribute advertisements to different Municipalities, Traditional Councils and also advertise through career exhibitions organised by the Department of Education. Applications are invited from well performing matriculants nationwide who wish to further their studies and pursue careers within the broader housing related fields. Applicants are required to attach a certified copy of ID, certified copy of June/May Grade 11 results and proof of financial disadvantage status (pay slip from parents)." she concluded.

Nyadzani Fulufhelo (25) from Ha-Makhuvha village in Thohoyandou is a Bachelor of Urban and Regional Planning graduate from the University of Venda. He is one of the beneficiaries of the Scholarship. He enquired about it when he was doing his Matric at Muhuyuwathomba Secondary School in 2008, applied and was successful. He started

working for the department of CoGHSTA in 2014 after completing his Tertiary studies. "I would have not been able to further my studies due to financial constraints. This was a great opportunity as it introduced me to an environment where I can help empower others through various planning projects", he said

Caiphus Molamodi (29) from Sekororo Village in Tzaneen also benefitted from the Programme. He obtained a degree in Urban and Regional Planning from the University of Venda in 2009. "In 2007 the Department of Human Settlements hosted a career exhibition at the University of Venda and they were also looking for best students studying Construction and Town Planning related courses. I applied and the rest is history", he said. He is permanently employed within the Department.

he MEC for CoGHSTA, Mme Makoma Makhurupetje delivered the Department's budget speech on Tuesday, 12 April 2016 at Lebowakgomo, Limpopo Legislature. Tabling her detailed 20 page speech, Makhurupetje said the Department is moving forward, is on the right track and not looking back. "Evidence proves that work is being done to restore dignity to the poor and hope to the homeless". She indicated that the Department, for the financial year 2016/17 has been given a budget of R2, 286 billion and the final allocation is as follows: The MEC went further to say that: "We are proud to join the rest of South Africa in celebrating the delivery of 4.3 million houses built countrywide which are continuing to benefit over 16 million people. As Limpopo, we have built and handed over 310 016 units which benefited millions since 1994. It is a good story

Makhurupetje also highlighted that the historical challenges faced by the Department regarding Human Settlements have become a thing of the past. "Our original target for 2015/16 was 8565 with only 3008 units approved on roll over amounting 11573. We therefore report that our performance has moved from 2065 housing units which is 20% in 2014/15 financial year to 8634 completed units in 2015/16 financial year which translate to more than 100% on the unitswe find it more encouraging that work in progress during the same period yielded 3084 housing units which are at foundations and wall plates levels thereby constituting 26% drawing

PARTICIPATE IN THE 4th LIMPOPO EPWP SUMMIT





The Limpopo Department of Public Works closed off the month of June on a high note by hosting the 4th Extended Public Works Programme (EPWP) Summit from the 28TH to 29TH of June 2016.

The Departmental Local Economic Development (LED) team took part in the two day EPWP summit, held at St Marco Hall together with representatives from local and district municipalities and South African Local Government Association.

During his address, the Premier of the Province, Mr Stanley Mathabatha explained that the EPWP is a programme aimed at alleviating poverty amongst the people of Limpopo province.

"This particular programme has, since 2004 assisted and will continue to assist in providing work opportunities and income to people while contributing to the development of our province," he expressed.

Giving an overview of the programme, the provincial EPWP Chief Director within the Department of Public Works, Mr Walter Mothapo highlighted that Infrastructure and the Social Sectors were at a low percentage of 16% and 38% respectively.

"Although the programme has had achievements there are still challenges that we have encountered such as planning, non-compliance to legislative directives and payment below EPWP minimum wage," he

The EPWP Chief Director further advised that commissions should give more attention to the two mentioned sectors and challenges and come up with solutions during the break away sessions

A representative from SALGA, Mr Vincent Mabunda said that although majority of municipalities have incorporated EPWP tasks within their departments, there is a need to improve the coordination process of the programmes projects.

"Practical visibility of officials in some of the EPWP projects is key in giving credibility to the EPWP process," he advised during his presentation.

COGHSTA TO DELIVER YET ANOTHER GROUND-BREAKING

DEVELOPMENT FOR THE MARAPONG COMMUNITY IN LEPHALALE

In a quest to deliver much affordable housing for the community the Limpopo Department of Cooperative Governance Human Settlements and Traditional Affairs (CoGHSTA) is planning to build the Marapong Community Residential Units (CRU) in Lephalale.

According to Mr Solomon Mpyatona, a Project Manager within the Human Settlements Development division in the department, the CRU program is aimed at facilitating the provision of secure and stable rental tenure for lower income individuals earning between R800 and R3500 a month who are unable to enter the formal private rental and social housing market.

"The development of the Marapong CRU is scheduled to be implemented in 2 phases to

produce a total of 514 units. The entire project is planned to be accomplished in 18 months with phase 1 being earmarked for completion within the 2016/17 financial year," he said.

The Project manager shared that the township establishment and site development plan have been approved by the Lephalale Municipality. Furthermore, the socio survey has been updated and beneficiaries checked on the Housing Subsidy System (HSS). Mpyatona added that he units planned to be built vary from 1 and 2 bedroomed houses, single and elevated, and designated units for disabled persons.

"There are currently old hostels on the site which the units are to be built. However, the Housing Development Agency (HDA) has appointed a Social Facilitator who together with the Lephalale Municipality will relocate the existing hostel dwellers to Altoostyd before construction can commence," he added. He further indicated that although the dwellers will be placed in Altoostyd temporarily, they will make sure that they have access to all basic services and are treated fairly.

Housing Development Agency (HDA) has completed the appointment of engineers and CoGHSTA has appointed Rheiland Investments CC/QINISA Construction Gauteng PTYLTD to ensure that all operations of the project are in full swing, and will be completed within the scheduled time frame, according to Mpyatona.

AWARD-WINNING COGHSTA, BREAKING NEW GROUNDS THROUGH INCLUSIONARY HOUSING!

olokwane – People who earn more than R3 500 earn too much to qualify for an RDP but too little to qualify for a bond can now breathe a sigh of relief, thanks to the developments taking place at Bendor Extension 100. The project, a first of its kind in Limpopo is located at Bendor Extension 100, an upmarket suburb in Polokwane. The development is based on two sectional titles yielding 661 units. With such projects, The Department of Co - operative Governance, Human Settlements and Traditional Affairs (CoGHSTA) is breaking new ground and on its quest to fulfill its mission of providing integrated sustainable human settlements.

The development is structured in 5 phases, with each phase comprising a number of units and collectively adds up to 661 units. These units consist of single and elevated buildings of which 198 are for rental and the rest are for sale. The project is public private partnership between CoGHSTA, Mabone Building Contractors, Living Large properties, Housing Development Agency and other relevant stakeholders.

The aim of the project is to facilitate the development of an integrated human settlement on well located land providing access to urban amenities, including places of employment whilst aiming at creating social cohesion amongst its residents.

It also aims to accommodate middle income earners who are alienated by the economical etiquette to afford town houses or bonds. These are individuals who earn too high to qualify for RDP houses and less to qualify for a bond, with salaries that hover between R1500 and R15000.

There are already 200 units sold and the bonds which have been approved. CoGHSTA and Polokwane Municipality have also identified a further 5000 qualifying applicants who are on

the list. Currently 19 units have been fully completed and ready for occupation and 15 units in process of completion.

The Department has already spent around R58 million on lands, roads, sewages and other services. This effort by CoGHSTA is in line with the national Department of Human Settlements strategy for the 2014 to 2019 medium term strategic frame work that focuses on policy and funding reforms that seek to achieve 1.4 million new housing opportunities; better spatial planning; better resource allocation; ensuring that poor households have adequate housing in better living environments and supporting the development of a functional and equitable residential market. It also points to the relevant direction of the department gearing up to deliver 80 000 housing units by 2019. This is indeed the process of producing a good history and story to tell in future.

According to MEC for CoGHSTA, Mme Makoma Makhurupetje, "we want a province

where all of our people have access to basic services and all other amenities in the proximity. I also want to make it clear that we will place the most vulnerable members of our society high on our priority list when we allocate houses," she

The brand new offices were handed over by Premier Stan Mathabatha on Friday, 29 April 2016 at Moletji village, Polokwane Municipality.

Kgoshi Kgabo Moloto III thanked the government for the offices and said they will really assist the community.

Speaking during the event, Premier Stan Mathabatha said: "We are doing this because as I have said during the Opening of the House of Traditional Leaders Chapter 12 of the Constitution of the Republic of South Africa enjoins this democratic government to recognize and support the institution of traditional leadership. On the other hand, the Traditional Leadership and Governance Framework Act of 2003, provides a mechanism for this support and, more importantly, the role of traditional leaders in society".

Ntona Mmakwena Manamela (67), a pensioner from Moletjie, Ga-Kgorosi village was very happy with the offices provided. "Now that the offices have come closer, we no longer have to travel long distances to get access to services and costs of traveling to town will be cut". said Manamela

Issues pertaining to developing the economy of the province were the order of the day when the Department of Economic Development, Environment and Tourism (LEDET) held a seminar with traditional leaders on 14 June 2016.

The Seminar that took place at Tiveka Game Lodge did not only have Traditional Leaders within the province present but representatives from different departments such as Agriculture and Rural Development and Land Reforms as well.

Welcoming attendees, MEC for Co-operative Governance, Human Settlements and Traditional Affairs (CoGHSTA) Mme Makoma Makhurupetje said that she was grateful that the Department of Economic Development, Environment and Tourism hosted such an event specifically with traditional leaders.

"LEDET is best placed to address the economic challenges of the province and with constant consultation with traditional leaders can assist with growing the economy of the province with regards to agriculture, arts and culture, mining, safety and etc," she said.

Adding that, CoGHSTA and LEDET value the role of traditional leaders in the administration of land and these kinds of workshops will strengthen the relations between traditional leaders and involved departments.

Chairperson of the Provincial House of Traditional Leaders, Kgoshi Malesela Dikgale expressed what a humbling experience it was to be part of the seminar with traditional leader

"We hope that the seminar will address issues such the issuing of liquor licences and the absence of game rangers which has led to trespassers destroying the natural vegetation in some areas in the province," he stressed.

MEC for LEDET, Mr Seaparo Sekoati said that Limpopo is 87% rural and as a department, we found it befitting that we host this seminar to consult traditional leaders as they are the heads of rural communities on how we can develop the province.

He then made a presentation on the state of the provinces economy, highlighting policy concerns, government's strategic goals, agriculture, tourism, the state of roads in the province, mining, tourism in the province.



LIMPOPO AIMS

s the Limpopo province prepares to enrol Initiates at respective and approved initiation Schools, the Department of Co-operative Governance, Human Settlements and Traditional Affairs recently hosted a Media Briefing Session to engage media houses on its readiness for the 2016 initiation season.

Scheduled to commence from the 18 June 2016 to 17 July 2016, House of Traditional Leaders Chairperson, Kgoshi Malesela Dikgale highlighted that this season, the department together with the House of Traditional Leaders aims for a zero death initiation season.

"The emphasis of initiates conducting premedical examinations by the House of Traditional Leaders this season will greatly assist schools in achieving a zero death rate at initiation schools," said the chairperson.

Kgoshi Malesela Dikgale also said that a total of 325 initiation schools were approved, 89 in Capricorn, 53 in Mopani, 118 in Sekhukhune, 44 in Waterberg and 21 in Vhembe districts.


"Illegally operated initiation schools will be investigated, shut down with immediate effect and ultimately fined," he cautioned.

Addressing the issue of illegally operated initiation schools in villages, Kgoshi Eric Chauke, who is the Deputy Chairperson of the Provincial House of Traditional Leaders stressed on how parents should each year ensure that they enrol initiates at listed approved initiation schools by the department and Provincial House of

Traditional Leaders.

Kgoshi Solly Sekororo, attended to queries relating to the start of the initiation season affecting the initiates' performance at school. He assured that the opening of initiation schools will not affect the initiates' school work as the Department of Education has permitted pupils scheduled to go to initiation schools to be released.

"The initiation schools programme is scheduled in such a way that will not disrupt or clash with the initiates' academic calendar. Through consultation with the Limpopo Department of Education, we were granted permission to go ahead with the initiation programme as most pupils are usually done with their exams a week before the school calendar closes," he concluded.

The trend of entitlement where we even club up certain members of the community to rally around us and destabilize the governance of municipalities and our communities will not help us at the end".


